

**Insecticide VI-POWER GEL Ready-to-use Syringe for Cockroaches in Gel**

Imidacloprid 2.15 % w/w

**DESCRIPTION:** Vi-Power Gel is a ready-to-use insecticidal bait in gel form for the control of cockroaches' German cockroach (*Blattella germanica*), Eastern cockroach (*Blatta orientalis*), Brown-banded cockroach (*Supella longipalpa*), American cockroach (*Periplaneta americana*), indoors, in cracks and crevices.

**DOSE(S) AND FREQUENCY OF APPLICATION:** The dose 1-3 drops/m<sup>2</sup> is effective for small cockroaches' German cockroach (*Blattella germanica*)/Brown-banded cockroach (*Supella longipalpa*), while the dose 3 drops/m<sup>2</sup> is effective for large cockroaches [Eastern cockroach (*Blatta orientalis*)/ Αμερικανική κατάρπιδα (*Periplaneta americana*)]. The dose 3 drops/m<sup>2</sup> required in case of high infestation or where Eastern cockroach and American cockroach predominate.

One (1) drop of approximately 6-7 mm diameter corresponds to 0,08 g of product. Regularly inspect the consumption of the product and replace it when it has been consumed.

Time to action (for population control): one (1) week after application

**INSTRUCTIONS FOR USE:**

- Apply the biocide product only in cracks and crevices. - It is recommended not to apply the product on very dirty surfaces or surfaces that are subject to frequent washing or where other insecticides have recently been used. - In any case, do not apply other insecticides or insect repellents to areas where the product has been applied. - Do not apply the product near heat sources (e.g., heaters). - For optimum effectiveness of the application, follow good hygiene rules: prevent contact with any kind of food. - Regularly inspect the consumption of the product and replace it when it has been consumed. - To avoid the risk of resistance (physiological or behavioral) it is recommended to use the product as part of an integrated program for cockroach control that provides for the use of insecticidal formulations with different mode of action and active substances. - Up to one (1) application per week. - Wash hands after applying the product and before eating, drinking, or smoking. - At the end of application, remove any residual bait and dispose of it in accordance with local regulations. - Read the label or leaflet before use and follow the instructions. - Inform the authorization holder if the application is ineffective.

**RISK MITIGATION MEASURES:**

- Apply the product safely in areas inaccessible to children, pets, and non-target animals. - The product must be applied safely to minimize the risk of consumption by other animals or children. - Avoid contact with the surfaces to which the product has been applied. - Avoid applications in the presence of uncovered food and feed, or in areas where food utensils or food processing surfaces are likely to be in direct contact with and contaminated by the product. - Apply only in covered areas that are difficult to access and away from water.

**POSSIBLE SIDE EFFECTS DIRECT OR INDIRECT, FIRST AID INSTRUCTIONS AND EMERGENCY MEASURES TO PROTECT THE ENVIRONMENT:**

**Possible direct or indirect effects:** May cause an allergic reaction.

**First Aid Measures: IF IN EYES:** Rinse cautiously with water for 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. **IF ON SKIN:** Wash with plenty of soap and water, without rubbing. **IF SWALLOWED:** rinse mouth. Do NOT induce vomiting or give anything by mouth if the patient is unconscious. Seek medical advice. If necessary, take the patient to a health center and have the package or label with you if possible. NEVER LEAVE THE PATIENT ALONE!

**STORAGE CONDITIONS AND SHELF LIFE OF THE PRODUCT UNDER NORMAL STORAGE CONDITIONS:** Keep the package closed, in a cool and well-ventilated place, away from frost and heat sources. Store away from light. Shelf life: 36 months (3 years) from the date of production indicated on the packaging.

**OTHER INFORMATION:** The product contains a bittering agent which makes it repellent to humans or pets.
